## **Faculty Voting Policy**

The policy for Voting in Departments and Programs in FAS, as indicated in the *Faculty Handbook* (Section IV.F.1), is as follows:

All voting on multi-year appointments and promotions must be done with secret ballots. For an appointment to be carried to the appropriate appointment and promotions committee, the candidate must receive affirmative votes from a majority of those present and eligible to vote. Note that voting criteria for associate professor on term (untenured) differs depending on whether the appointment is governed by FASTAP 2007 or FASTAP 2016.

## **Confidentiality Policy for Department Members**

Yale's tenure and promotion deliberations are confidential. This confidentiality enables faculty members to have open and honest exchanges that help ensure deliberations of the highest quality, which is in the best interest of the faculty member under consideration, the department, and the University. Preserving confidentiality not only allows the university to carry out its work, but also it is the law. Connecticut law protects employee records, including those that relate to promotion and hiring.

Faculty participating in tenure and promotion cases also must maintain the confidentiality of the content of department deliberations. Communication about the content of formal deliberations, the "gist" of discussions (even without attributions of specific comments to particular sources), the identity of letter writers, the content of referees' letters, or information about the vote (other than whether it was affirmative or negative) represents a breach in confidentiality. There is no time limit for this confidentiality.

Chairs serve as the only spokespeople for their departments. They or their official designees are the sole means to convey to candidates decisions made by the department or the promotions committee and the reasons for those decisions. Department members should direct any questions about the deliberations or materials for a case to the Department Chair.

<sup>\*\*</sup> Within the FAS, faculty members holding secondary appointments in the following departments and programs may have the same voting privileges (including the privilege to vote on tenure appointments) as those with primary or fully joint appointments: American Studies; Black Studies; Comparative Literature; East Asian Languages and Literatures; Ethnicity, Race, and Migration; Film and Media Studies; Women's, Gender, and Sexuality Studies. For the following departments and programs an Executive Committee serves as the full voting body on all matters of curriculum and appointment: Cognitive Science; Humanities; Italian Studies; Jewish Studies; Spanish and Portuguese; and Theater, Dance, and Performance Studies. Faculty with primary or fully joint appointments in these departments or programs constitute the permanent members of the committee. The additional members of the Executive Committee may be drawn from faculty in the FAS or, with the permission of the FAS Dean, a professional school. Typically they serve 3-year, renewable terms.

## **DEPARTMENT FACULTY VOTE Faculty of Arts and Sciences**

Use this form to record the results of a departmental faculty vote for a candidate being considered for an initial appointment, a reappointment, or a promotion. Only those present may vote, and all those who participate in the meeting until the completion of the deliberations are expected to vote. Voting options are Yes, No, or Abstain. No polled or absentee ballots may be counted. This vote must take place by secret ballot. As stated in the *Faculty Handbook*, "the candidate must receive affirmative votes from a majority of those present and eligible to vote" for the case to move forward in the appointment or promotion process.
